PLAGIARISM?

MLA vs APA vs CHICAGO

MLA

- features brief parenthetical citations in the text keyed to an alphabetical list of works cited that appears at the end of the work
- Used in language and literature writing

In text Citation: Imperialism is "the practice, the theory, and the attitudes of a dominating metropolitan center ruling a distant territory" (Said 9).

In text Citation: According to Edward W. Said, imperialism is defined by "the practice, the theory, and the attitudes of a dominating metropolitan center ruling a distant territory" (9).

Work Cited

Said, Edward W. Culture and Imperialism. Knopf, 1994.

APA

The author's last name and the work's date of publication must always appear, and these items must match exactly the corresponding entry in the references list.

In text citation:

"The potentially contradictory nature of Moscow's priorities surfaced first in its policies towards East Germany and Yugoslavia," (Crockatt, 1995, p. 1).

Book Citiation in Bibliography: Baxter, C. (1997). Race equality in health care and education. Philadelphia: Ballière Tindall.

Chicago

Incorporates rules of grammar and punctuation common in American English. Typically, Chicago style presents two basic documentation systems: (1) notes and bibliography and (2) author-date. Choosing between the two often depends on subject matter and the nature of sources cited, as each system is favored by different groups of scholars.

presents bibliographic information in notes and, often, a bibliography Book Citation:


